At least 30 days prior to the commencement of any residential lease term, the Owner shall submit the following to Denton Manor Property Owners Association, Inc. (DMPOA):

- (1) this completed Rental Agreement Form,
- (2) the nonrefundable application fee, and
- (3) a copy of all background check(s) of any tenant(s) 18 years and older.

The application fee is \$100 for each year or fraction of a year and shall be paid in full by the Owner when this Rental Agreement Form is submitted initially. All forms and background check(s) are due 30 days prior to the commencement of any lease term. **Forms submitted less than 30 days prior are subject to an additional \$100 fee for expedited processing.**

Example 1: A one-year lease, or any lease less than one year, requires an application fee of \$100.

Example 2: Any lease that is more than one year, but is two years or less, requires an application fee of \$200.

For multi-year leases, **a new Rental Agreement/ Rental Renewal Form and current background check(s) for tenant(s) 18 years and older are required for each subsequent year of the lease and must be submitted no later than 30 days prior to the yearly anniversary of the rental start date.**

Example: For a three-year residential lease, if the lease term begins on October 1, 2018 (after the initial Rental Agreement Form, full application fee, and background check(s) have been submitted), a new Rental Renewal Form shall be submitted no later than September 1, 2019 and September 1, 2020, along with current background check(s) for any tenant 18 years or older. This example requires an initial application fee of \$300, which shall be paid by the Owner, when the first Rental Agreement Form is submitted.

- Any Owner who fails to comply, or whose Tenant fails to comply, with the Restrictive Covenants and their First Amendment, as well as the terms of this Form, shall be in violation thereof and subject to direct assessments.
